#### **Success Cultivating Diversity in Academia**

I currently chair 5 doctoral students at Texas A&M University

- ALL women of color; 3 Black/African American, 1 Hispanic/Latina, 1 Muslim
- 4 of 5 (80%) intending to pursue academic careers

As of July 2023, I have formally chaired/co-chaired to completion (earned doctorate) 31 doctoral students.

- 68% (N=21) are first generation college students
- 87% (N=27) are women
- 90% (N=28) are from racial/ethnic minority groups
  - 55% (N=17) Black/African American
  - 10% (N=3) Hispanic
  - 19% (N=6) Asian of which 33.3% are from Asian subgroups grossly under-represented in academia and over-represented among populations adversely impacted by health inequities
- 84% (N=26) immediately pursued academic/research careers (e.g., postdocs, faculty positions)
- 77.4% (N=24) are still in academic/research careers

These numbers reflect only those for whom I am officially listed as chair/co-chair. These do not reflect the 24 additional doctoral trainees I mentored. A comprehensive list is available upon request.
